APPROVE A RESOLUTION ADOPTING THE AGREEMENT BETWEEN NOBLE AMERICAS ENERGY SOLUTIONS LLC AND THE PENINSULA CLEAN ENERGY AUTHORITY FOR PROVISION OF DATA MANAGEMENT SERVICES AND ESTABLISHMENT OF A CUSTOMER CALL CENTER FOR A TERM BEGINNING IN APRIL 2016 AND ENDING JULY 1, 2018 IN AN AMOUNT OF \$1.15 PER ACTIVE METER PER MONTH

Mr. Silberman gave a brief description of all the changes made in the agreement since the last draft. The Committee and Mr. Silberman discussed various changes that could be made to the agreement.

Motion to approve a resolution adopting the agreement between Noble Americas Energy Solutions LLC and the Peninsula Clean Energy Authority for provision of data management services and establishment of a customer call center for a term beginning in April 2016 and ending July 1, 2018 in an amount of \$1.15 per active meter per month with direction to staff to attempt to negotiate a definition of an enrollment period, a provision allowing staff to monitor calls, and the addition of Board members to the hold harmless provision
