REGULAR AGENDA

1. CHAIR REPORT

Dave Pine—Chair—welcomed the Executive Committee members to Peninsula Clean Energy's (PCE's) new office at 2075 Woodside Road.

2. CEO REPORT

Jan Pepper—Chief Executive Officer—reported that staff made offers to three new employees who will be starting on September 20th: TJ Carter for the Marketing Associate position, and Charlsie Chang and Alejandra Posada for the two Outreach Fellow positions. Jan also announced that she made an offer to Jay Modi for the Director of Finance and Administration position, to start the end of September.

Jan reported that PCE staff will be coordinating with Calpine to have PCE's rate change coincide with PG&E's January 2018 rate change. Discussion centered around public disclosure of, and projections for, changes to PG&E's rates and the PCIA.

Jan reported that CalCCA (California Community Choice Association) will hold their annual meeting on October 3rd in Riverside, California, with a focus on newly formed CCAs (Community Choice Aggregation). Jan also announced that PCE is planning a celebration in October when PCE reaches its one-year anniversary.

3. REVIEW BOARD RETREAT AGENDA

Jan Pepper reviewed draft topics for the Board Retreat agenda. Discussion centered around PCE's strategic goals and progress on PCE's Integrated Resource Plan.

4. LOCAL PROGRAM EVALUATION CRITERIA PROGRESS

Kirsten Andrews-Schwind—Communications and Outreach Manager—reviewed a draft of the local program selection process and criteria. The committee members discussed evaluation criteria and different types of programs.
