SUBJECT: Community Outreach Grants Update

BACKGROUND:

In 2018 Peninsula Clean Energy (PCE) conducted a successful community outreach grant pilot program to create and enhance partnerships with community organizations to expand PCE's overall outreach. This initial effort focused on education on PCE to prevent opt-outs and resulted in 100,000 PCE impressions in five languages. In June 2019 PCE issued an RFP for nonprofit organizations and local government agencies to collaborate with PCE on a second round of outreach grants communicating our current key messages in general, with the goal of providing some grants to focus on underserved populations and some grants to focus on general education about building and transportation electrification. Proposals were due July 31, 2019.

DISCUSSION:

PCE is pleased to report that we received nine applications for our community outreach grants, eight with complete work plans. Note that organizations were eligible to submit more than one application.

Staff are in the process of evaluating proposals. Proposals with complete work plans were received from the following organizations:

(1) Sound of Hope Radio Amount Requested: \$40,000

Goal: Communicate basic PCE messages and programs to Chinese-speaking community through a variety of marketing tools including radio ads and interviews, inperson workshop, videos, and digital media.

(2) Peninsula YMCA

Amount Requested: \$10,450

Goal: Leverage existing relationships to conduct target outreach to hard-to-reach and underserved communities with PCE messages. The proposal focuses on three audiences: afterschool enrichment program participants, high school program participants, and Peninsula Family YMCA members.

(3) Acterra

Amount Requested: \$40,000

Goal: Communicate PCE's key messages through two existing Acterra programs:

- 1) GoEV Program Provide local citizens with hands-on opportunities to experience electric vehicles and raise awareness that there is an EV to suit every budget.
- Community Resiliency Provide education and outreach programming to lowincome communities about PCE billing, discount programs, and used EV program.

(4) Menlo Spark & Housing Leadership Council

Amount Requested: \$40,000

Goal: Engage affordable housing developers about the benefits of all-electric, affordable housing. Explore and develop strategies to prevent cost increases from being passed down to renters. Educate other community leaders and local government staff on all-electric housing.

(5) Sustainable San Mateo County

Application A

Amount Requested: \$39,790

Goal: To inform the community about PCE, SSMC proposes to host eight community gatherings throughout the County, hold a hackathon for Millennials, produce paid social media campaigns, as well as other outreach actions.

(6) Sustainable San Mateo County

Application B

Amount Requested: \$40,000

Goal: In parallel with Application A, this application focuses on outreach to SMC residents through faith communities. Conduct outreach to about 170 congregations to help them get funding and technical support for EV chargers, set up workshops at places of worship on energy efficiency, and work with faith leaders to plan services with a theme of environmental stewardship.

(7) Sustainable Future Outdoor Academy

Amount Requested: \$120,000 in the form of three \$40,000 grants (through one application)

Goal: The SFOA is a Boy Scouts Pacific Skyline Council outdoor camp curriculum that combines hands-on activities, field trips to local destinations, and educational lectures about climate change. They are requesting funding to expand this curriculum to public and private schools in San Mateo County, as well as improve the quality of the program. Students do not have to be members of the Boy Scouts to participate.

(8) El Concilio of San Mateo County

Amount Requested: \$40,000

Goal: Communicate basic PCE key messages, specifically around cost-savings and eligibility for PCE's used EV program, to mainly Spanish-speaking communities in San Mateo County. Includes tabling at community events, one-on-one case management, radio ads, and presentations.
