Hi all at CalCCA, MCE Clean Energy, Peninsula Clean Energy, and Silicon Valley Clean Energy,

It is with great respect for all of the work you do to reverse the climate crisis, and the work you have done with myself and other climate organizers, that I express my deep concern at the involvement of MCE Clean Energy, Peninsula Clean Energy, and Silicon Valley Clean Energy in The Climate Center's "Investing in Farmers for Nature-based Carbon Sequestration" webinar next Wednesday July 28.

As a long time climate and environmental activist I need to point out the spurious nature of the 'regenerative' ranching 'carbon farming' being promoted by The Climate Center, and how its partner in the event Straus Family Creamery (and other ranchers/grazers) are using such events to greenwash their bad environmental practices (including calling for the killing of rare California Tule Elk for competing with their livestock). These ranchers are deeply harming the Point Reyes National Seashore ecosystem in a manner totally at odds with everything the environmental movement represents.

Below is a letter that I wrote to The Climate Center a year ago when they hosted a very similar event (a letter which they apparently ignored) detailing the problem with these ranches/dairies (including Straus specifically) and how they have been openly hostile and harmful to wildlife. Please see this letter for evidence and links showing why we should all be opposing what The Climate Center and Straus are promoting.

Also see the following three links which show very clearly that the ranching/grazing methods being promoted simply do not work and would actually increase carbon emissions if they were expanded broadly as a climate 'solution'.

- 1) Graphic showing the far longer time to slaughter weight of grazed livestock. Here is the letter to The Climate Center.

On 5/21/2021 7:00 PM, Eric Brooks wrote:

I was concerned to see that a Climate Ag event hosted by The Climate Center also prominently features Albert Straus of 'Straus Family Creamery'. Straus has been openly asking the National Park Service to kill and remove rare Tule Elk from Point Reyes National Seashore park (which was founded in large part to restore the elk). Straus and others are pushing this because the elk compete with cows and other ag herd animals on dairy farms and ranches that are outrageously still allowed to operate in the park (and are destroying it).

In short, Albert Straus is not at all the face that the regenerative agriculture movement should be putting forward.

Here are the details, with links to the comments of Straus and other Point Reyes farming operations, made to to the National Park Service, calling for the removal of the elk.

Point Reyes Crisis

As you might know, there is an urgent crisis in the Point Reyes National Seashore park in Marin County in which its National Park Service managers have established a plan to cull the wild Tule Elk in the park to keep them from competing with grazing livestock and farming operations there.

Some making profits from so called 'sustainable' 'regenerative' dairy and ranch operations that are devastating the Point Reyes National Seashore habitat are demanding the killing of returning wild Tule Elk. (Note: See the video links near the end of this email for two documentaries that lay out the destruction caused to the park and the elk by the agricultural operations.)

Marin Carbon Project Greenwashing

Three of the 'sustainable' 'regenerative' dairies/ranches making a profit from ranching in the Point Reyes National Seashore park, Straus Family Creamery, Stemple Creek Ranch, and Gilardi Family Farm, are greenwashing themselves as the three showcase farms of the Marin Carbon Project.

The involvement of these dairies/ranches directly implicates Marin Carbon Project with animal agriculture attacks on wildlife - the opposite of ecological sustainability.

Dairies/Ranches/Farms Calling For Tule Elk To Be Removed

- To see Straus Family Creamery founder Albert Straus pushing in public comments for dairies to continue to be allowed to operate in Point Reyes National Seashore and calling for the restored Tule Elk herd to be removed search for "2683" in the document at the following link. In those remarks Straus specifically invokes Marin Carbon Project to justify his statements, and says "As part of prioritizing organic agriculture as a vital contributor to Marin County's economy, I ask that GMP Amendment process includes removing all free-range Tule elk from the Pastoral Zone and all farmlands."

- To see Brian Gilardi of Gilardi Family Farm (who directly profits by selling grain and hay to the dairies and ranches operating in the park) pushing in his public comments for the farms to remain in the park and for the Tule Elk to be 'managed' (which would mean their being removed from much of their current habitat) so that they don't interfere with the farms, search for "Gilardi" at: https://www.nps.gov/pore/getinvolved/planning\_gmp\_amendment\_initial\_public\_comments\_2501-2750.htm
