

MEMBER'S RESOLUTION

PENINSULA CLEAN ENERGY

WHEREAS, For its distinguished record of public service and immeasurable contributions to the advancement of clean, affordable electricity in San Mateo County, Peninsula Clean Energy is deserving of special public recognition and the highest commendations as it celebrates its fifth anniversary;

and

WHEREAS, Created after receiving approval from the San Mateo County Board of Supervisors and each of the 20 cities and towns it serves, Peninsula Clean Energy was established with the vision of giving residents a clear community-led choice in their electricity generation, and since its inception in 2016, it has reinvested in local communities and provided residents with electric transportation and appliance rebates, assistance on home upgrades, clean emergency backup power for medically and wildfire-vulnerable residents, and bill credits during the COVID-19 pandemic;

WHEREAS, Having transformed San Mateo County into a recognized leader in renewable energy generation and consumption, building electrification codes, electric transportation, and the provision of clean and affordable electricity, Peninsula Clean Energy has succeeded in reducing more than 1.2 million metric tons of heat-trapping carbon dioxide emissions while simultaneously providing residents and businesses more than \$90 million in electricity cost savings, demonstrating its ability to deliver cleaner and greener electricity at a lower rate;

and

WHEREAS, By providing its customers with 50 percent renewable energy in 2016, Peninsula Clean Energy accelerated its efforts toward reaching California's clean energy goals, and having continued to lead the way by providing all its customers with emission-free power beginning in 2021, considerably ahead of California's 2045 zero-emission power mandate, it is moving toward a nation-leading goal of providing 100 percent renewable energy 24 hours a day, 7 days a week, by 2025;

WHEREAS, Throughout its history, Peninsula Clean Energy has been a leader in the utility sector by providing clean, affordable electricity to local residents and businesses, and it has steadfastly pursued its goal to positively impact the cities and towns of San Mateo County by providing renewable energy options; now, therefore, be
